

Employer Information Contributions & Choice of Fund

June 2016

The following outlines information required by employers to comply with obligations under the *Superannuation (Guarantee) Administration Act 1992* to make minimum contributions for employees within required time limits and to comply with an employee's choice of superannuation fund.

Pitcher Retirement Plan is a complying fund

Pitcher Retirement Plan (ABN – 15 828 677 472, SFN – 508210, SPIN – n/a) is a resident regulated superannuation fund. The Trustee of the Plan is Pitcher Retirement Plan Pty Ltd (ABN – 77 092 941 574, ACN – 092 941 574). Please contact us if you require additional forms.

If you are unable to provide a remittance advice form, you can e-mail or fax contribution information to us. As a minimum, the following information must be included for us to be able to allocate the contribution:

- Employer name
- Full name of employee/member
- Employee/member membership number in the Plan
- Amount contributed for the employee/member
- Period for which the contribution relates (e.g. June 2017 quarter)
- The date the contribution was made to us
- Information regarding the type of contribution(s) (e.g. employer SG contribution, salary sacrifice contribution, after-tax contribution).
